Dear Senator Abetz:

Thank you for your letter dated 20 November 2015 (copy enclosed) to which I respond.

The enclosed copy of my letter to Mr. Tony Abbott and the enclosed copy of a recent letter to my representative in the House of Representatives, Mrs. Jane Prentice (Liberal – Ryan, Queensland) compile facts from eight years investigating climate and even I was stunned with what the latter revealed about the Coalition's behavior. I please request your assistance in helping Mrs. Prentice to fulfill her responsibilities and to assist Mr. Abbott to restore integrity to the Liberal Party.

I hope that the irrefutable logic and facts in my letter to Mrs. Prentice will stimulate you to encourage fellow Members of Parliament to recognise the dangers to governance and sovereignty in current Liberal Party policy, and to then restore integrity to parliament and to restore Australian sovereignty and governance.

I am available to meet with you to discuss this and to be questioned on my documented data and facts.


