Please refer to the enclosed copy of recent correspondence with the University of Queensland Vice Chancellor, Professor Høj. Key points are in red text. Please note questions 7, 8, 9, 10, 11, 12, 13, 14, 17, 18, 19, 20, 21, 23, 25, 27 and 30.

I am concerned that the University is misappropriating taxpayer funds and actively destroying Australian sovereignty, governance and industry. A senior member of staff, Professor Ove Hoegh-Guldberg, has close working relationships with Greenpeace and WWF. His claims, as reported publicly and made under oath or affirmation in Queensland's Land Court, are false and unfounded. They support Greenpeace's public strategy for destroying Australian industry.

I request that your department thoroughly investigate the University's use of taxpayer funds and thereafter restore scientific integrity and accountability in tertiary education and protect Australian sovereignty, exports and employment.
