Dear Mr. Cutifane:

Re: Ending the war on hydrocarbons including coal

Thank you for your 22 December 2014 reply to my letter dated 8 December 2015. Your promptness is appreciated. This reply has been delayed to include reference to a report just completed in response to a letter from Australian Senator Simon Birmingham.

Your reply is confusing since it appears to respond to me as if I support the claim that carbon dioxide (CO₂) from human activity causes harmful climate change and am challenging AngloAmerican's production of coal. Your reply defends your posture in addressing "*the challenge posed by climate change*" when my letter was about the exact opposite - supporting you as a coal producer and hopefully making your job easier by revealing the truth on climate change. Specifically, there is no need to curb the use of hydrocarbons because "*carbon*," or correctly, carbon dioxide (CO₂) from combustion of hydrocarbons, is neither a pollutant nor is it causing the earth's climate to vary. I provided you with scientific evidence supported by many references that refute what we have all been told by the UN Intergovernmental Panel on Climate Change (IPCC) and by some governments and extreme activists that chose to spread the politically manipulated conclusions in UN IPCC reports.

It is understandable that you were willing to sign your reply as written since it did not respond to the letter that I wrote. If the evidence that my letter contained had been investigated I do not believe you would have been willing to sign your letter since your response supports false conclusions contrary to the facts that I presented. I briefly reiterate now what was said in my previous letter: your trust in the UN IPCC's claims of human activity causing damaging global climate change is misplaced. By your reply it is clear that your continuing acceptance of the conclusions of the UN IPCC reports is causing you to waste resources on re-jigging your future portfolio of products to eliminate coal and scrambling to "*take action ... tackling our own carbon footprint adapt ... develop ... adopt reduce ... working ... addressing...*". I can though empathise with the challenge you perceive in managing fabrications spread by the media, extremists and a diminishing yet vocal Greens political rump.

Please refer to the enclosed four-page extract from my report of 27 February 2015 to The Hon Bob Baldwin MP and Senator Simon Birmingham. The full report presents seven years' independent investigation by succinctly summarising climate data and science, revealing the UN IPCC's misrepresentations, motives and unwitting accomplices, and detailing the costs to nations and industry. The ultimate arbiter of science is honest, rigorous statistical analysis of observed data, not unvalidated and erroneous computerised numerical modeling, fabricated 'consensus' or the appeals to authority upon which political climate claims and, implicitly, your letter rely.

Specifically, and to be clear about the documented extensive corruption of climate science by the UN IPCC's reports, please refer to Appendix 2 (<http://bit.ly/1snwKVB>) of my 2013 *CSIROh!* report and in particular to that appendix's section 15 pages 28-41, section 2 pages 7-11 and section 1 pages 4-6. As with all my work, it relies on publicly available facts including data from the UN IPCC itself and factually supported expert opinions from climate scientists familiar with, and in many cases part of, the UN IPCC's reporting processes. My report's appendices 6, 6a and 7 document the misrepresentations by a small group of Australian CSIRO and Bureau of Meteorology

(BOM) executives closely connected with the dishonest UN IPCC. If you perceive any material errors in my work please specify.

This latest report explains the rigorous, widely consultative and exhaustive processes I followed and that prove the UN IPCC has no empirical scientific evidence for its claim and has never presented any such evidence, that it actually contradicts empirical evidence and that its politically driven claims are false and rely on misrepresentations.

It is pleasing to see, though, in your reply that you acknowledge the importance of coal to the world with its continued use enabling the supply of affordable energy "*which underpins social and economic development*" liberating billions of people. What I don't understand is how you can hold both views at the same time - believing that coal is a culprit in causing detrimental climate variability, yet continuing to supply it at all? Since you now know the truth, that CO₂ is not the 'demon' that the UN and Green movement protestors are making it appear to be, that knowledge can be used to overturn manipulated public opinion and stop legislation intent on destroying the hydrocarbon industry for others's political and financial gain. It would certainly release AngloAmerican to redirect those resources currently funneled toward appeasing 'authorities on climate change' to maximise shareholder return and truly care for AngloAmerican's people.

Given your implicit strong belief that CO₂ from human activity causes detrimental climate variability, it should be simple for you to send me the exact location in the UN IPCC's reports – or anywhere else – of the data and analyses that you think proves that human CO₂ affects global climate. I request references to the *specific* location of *specific* empirical scientific evidence that justifies your commitment to taking action to address climate variability. If you cannot do so, I would expect AngloAmerican to cease activity serving the claim that human CO₂ causes global climate change, to proudly produce as much coal as possible, and to end the 'politically correct' rhetoric meant to assuage the politically-driven guilt about combustion of hydrocarbons that are falsely accused of harming our planet.

Any efforts made to try and stop the earth's natural climate variability are wasting shareholder funds, human resources and capital. These resources could be used to fulfill AngloAmerican directors' duty to maximise company value, to ensure corporate social responsibility and to care for your people. I would like the opportunity to assist you and the Chief Executive of AngloAmerican Coal, Mr. Seamus French in maximising the value of your company and of our industry. As stated in my previous letter, I offer my independent services, including my extensive body of work investigating climate science, to stop this war on hydrocarbons and to continue to "drive operational excellence" so more people globally can enjoy coal's benefits to our natural environment and to humanity.


