Dear Messrs. Roche and Pearson:

Re: Ending the war on hydrocarbons especially coal

Late last year Mr. Pearson you were copied on my letter of 8 December 2014 to executives leading five global coal mining companies.

Before sharing their replies I remind Mr. Roche that on Thursday, 7th October 2010 he participated in a Brisbane forum with Greens senator-elect Larissa Waters, WWF Australia Manager for Climate Change Kellie Caught, University of Queensland Honorary Research Associate Professor in philosophy William Gray and me. Despite your position as Chief Executive of the QRC and contrary to the empirical scientific evidence you agreed with the Greens, WWF and William Gray that hydrocarbon fuels need to be penalised, thereby making them less competitive. Toward the end of the forum I challenged all participants to a public debate and none accepted my challenge.

Since then I have completed seven years' independent research into the claim that human production of carbon dioxide (CO₂) causes climate variability. The claim has been proven false. Mr. Pearson has received my material and says it is "excellent". Yet, contrary to empirical scientific evidence, the Minerals Council continues to promote that hydrocarbons such as coal need to be burdened with needless costs making them less competitive. As explained in the enclosed copy of my letter to Australian coal executives together with an extract from my latest report, the Minerals Council's complicity is enabling a campaign by activists destroying our coal industry.


