The list of people to whom my Registered Post letter to Greg Hunt was copied shows that my local federal MP Jane Prentice was included.

I take this opportunity to respectfully remind you that this matter is not about global warming (aka *climate change*) and climate science. It's about corruption of climate science combined with serious misrepresentations of climate, science and Nature by a Minister of the Party you serve as Deputy Leader.

I seek of you please in that capacity and as a Minister upholding your parliamentary and ministerial oaths to restore integrity to government policy and prevent recurrence of Greg Hunt's misrepresentations.

May I remind you further that on a windy Sunday, September 18th, 2011 afternoon in Perth I personally handed you a document detailing extensive and fundamental corruption of climate science by the Labor-Greens government? You said you would read the document.
