**LAWFUL NOTICE BY REGISTERED POST WITH DELIVERY CONFIRMATION  
WITHOUT PREJUDICE AND IN GOOD FAITH**

Your attention is drawn to my letter to you dated February 4<sup>th</sup>, 2013 and to the attached document by Graham Williamson, dated March, 2013 and entitled *AGENDA 21: POLITICIANS SHUTTING THE DEBATE DOWN*, sub-titled *Response of the Shadow Minister for Climate Action, Environment and Heritage To Agenda 21*. This letter is being copied to my local representative in federal parliament, Ms. Jane Prentice.

My letter of February 4<sup>th</sup> accompanied my detailed report on investigations into CSIRO's claims on global warming. My report entitled *CSIROh!* encompasses 780 pages of appendices. It details extensive corruption of climate science by CSIRO and other agencies and individuals employed by government and funded by taxpayers.

In our past correspondence you have maintained your belief that human carbon dioxide (CO<sub>2</sub>) is causing global warming and global climate change. You have maintained your belief that human CO<sub>2</sub> needs to be cut. You have maintained both beliefs despite failing to provide empirical scientific evidence and logical scientific reasoning proving causation by human CO<sub>2</sub>. Your position and claims contradict empirical scientific evidence. You have ignored extensive, irrefutable documented evidence that the claim that human CO<sub>2</sub> drives global climate is based on extensive documented corruption of science.

Your position and your unfounded belief contradicting empirical scientific evidence are disturbing. That you developed and advocate a policy contradicting real-world evidence is my reason for asking you in my letter of February 4<sup>th</sup> to immediately resign from parliament unless you provide the necessary evidence and reasoning to justify your core claim about human CO<sub>2</sub>.

I now write to you about an additional and profoundly disturbing matter: your actions apparently supporting or at least enabling UN Agenda 21 and your claimed ignorance of same.

It is clear that fomenting unfounded global climate alarm is part of the UN's Agenda 21 campaign to instill unelected global governance, to gradually destroy Australia's national governance and sovereignty and to control the food, energy, movement, property, resources and finances of Australians. Yet in your email dated April 14<sup>th</sup>, 2012 to Peggy Balfour you said, quote: "*And no, I am not aware of the details of Agenda 21.*" In your email dated May 3<sup>rd</sup>, 2012 to Susan Colvin you said, quote: "*A genuine question...why were you silent on this issue for the first 19 years of the Agreement?*"

*It is not a trick question but a genuine inquiry.*

*In my own case, as I have said, no I was not aware of this issue...it was not until the last two weeks that I had any awareness that this was also the Rio Declaration.*

*If a council is using a 20 year old non binding international declaration to justify silly planning laws then that is plain ridiculous.” That was in response to Susan’s question earlier the same day about UN Agenda 21 when she said to you, quote: “I have been writing to you for over a year about United Nations Agenda 21 (signed by Australia in 1991 and again by Howard Govt in 2000).”*

My understanding of your background is that you have a Bachelor of Laws degree and that you were Senior Adviser to former Foreign Affairs Minister Alexander Downer in his various roles from 1994 to 1998. Those roles included Leader of the Opposition and Foreign Affairs Minister. You were Director of Strategy for the World Economic Forum in 2000 and 2001 a body aiding the push for global governance. This is your fifth year as Opposition spokesperson for the Environment. For over three years your responsibilities included Water policy. You served on the Joint Standing Committee on Treaties for over two years from June 2004. Now I’m stunned to receive Graham Williamson’s document detailing that you have been aware for many years of ICLEI, the International Council For Local Environmental Initiatives. It oversees implementation of UN Agenda 21 within councils worldwide. Graham has documented that in 2005 you presented an ICLEI certificate to Penrith City Council and quotes the then Mayor of Penrith, Jackie Greenow.

Graham’s document reflects his usual careful, comprehensive, thorough and well-referenced approach. I trust him and his documents.

In my experience, federal MPs are rightly very careful to understand the circumstances and backgrounds when presenting public awards. It is difficult to believe that in performing your due diligence on ICLEI you are not aware of its umbrella role for assisting councils across Australia to implement UN Agenda 21. Given your documented involvement in local initiatives it is stretching credibility to accept that you are not aware of UN Agenda 21 or ICLEI’s role supporting and coordinating implementation of UN Agenda 21 across Australia.

Given your background and current and former responsibilities I cannot imagine how any competent, intelligent person such as yourself could plausibly be ignorant of UN Agenda 21.

To be frank, Greg, these facts raise serious questions about your competency and/or your integrity. It is stunning that the federal Opposition Spokesperson on the Environment is ignorant of the nationally and globally most significant supposed ‘environmental’ program being implemented across Australia by national and state governments and local councils. How could you possibly be unaware that UN Agenda 21 is being implemented and implemented covertly and unconstitutionally? Given your background, how could you be unaware it is camouflaged as a so-called environmental program while really a UN program undermining national sovereignty and individual freedom worldwide?

My family and I together with all voters and Australians are entitled to answers from you. Could you please identify and/or provide specifically:

- The scientific basis for your claim that human CO2 caused global warming (aka climate change)? On which organisation do you rely for your claim? Is it CSIRO, the BOM, the UN IPCC, individual academics or other agencies? Please identify the specific reports

and data upon which you rely and specific parts of those reports that are the basis of your “*belief*”;

- Significant material errors, if any, in the attached report by Graham Williamson;
- Explanation for your deep and extensive involvement in various programs associated with UN Agenda 21 despite your claim to be unaware of details of UN Agenda 21?
- Your awareness or otherwise of consequences of adopting UN Agenda 21 undermining Australia’s sovereignty and governance and curtailing personal freedoms of all Australians? Given your legal background can you please explain why UN Agenda 21 is being implemented without endorsement by Australia’s parliament or people and with scant knowledge by Australian citizens? Do you agree that Australians are entitled to full disclosure of UN Agenda 21 currently being implemented across Australia?
- Whether or not as a Liberal MP in the Howard government you knew of John Howard’s alliance with then Queensland Premier Peter Beattie and then NSW state minister Bob Carr in removing private property rights from Australian farmers to comply with the UN’s Kyoto Protocol? Are you aware that removal of property rights was achieved without compensation as required under the Constitution of the Commonwealth of Australia? As Environment spokesperson are you not aware that property rights of farmers and coastal residents have already been removed under Liberal and Labor legislation and/or programs associated with the unscientific, unfounded and false claim that human CO2 caused global warming? Did John Howard’s cabinet not discuss his removal of farmers’ property rights when you were Senior Adviser to a senior Howard minister? Did the Coalition caucus not discuss his removal of property rights during your time as an MP? In your role as a Senior Adviser were you not aware of UN Agenda 21 implementation discussed by COAG (Council of Australian Governments)?
- Whether or not you are now aware that UN Agenda 21’s comprehensive framework of rules, regulations and restrictions undermines the philosophy akin to free-markets described in your speeches that you sent by email on April 7<sup>th</sup>, 2011? Am I to believe your speeches or your actions outlined in Graham Williamson’s document?

If you consider Graham Williamson’s document contains significant material errors please identify, specify and justify each by March 22<sup>nd</sup>, 2013. If you fail to identify errors by that date I will conclude that you agree that the document is accurate.

Your actions, claims and failure to adequately respond to Graham Williamson’s reasonable inquiries about a serious matter affecting him, all Australians and me are deeply disturbing. Unless you can by March 22<sup>nd</sup>, 2013 provide empirical scientific evidence and logical scientific reasoning as proof of the need to cut human CO2 emissions and unless you plausibly and accurately explain your involvement in or ignorance over many years of UN Agenda 21, I ask that you immediately resign from parliament.
